- Scholarship applicants must reside in Medina County.
- The Scholarship Committee maintains a strict non-discriminatory policy when considering and awarding the scholarship monies. Additionally, all information contained on this form remains strictly confidential.
- The amount of the Diane E. Guenther scholarship is \$1,000.00.
- The Medina Early Childhood PTA (MECPTA) is matching the Guenther family's donation of \$1,000.00; thus, two scholarship recipients will be selected to each receive \$1,000.00 to be used for attending preschool.
- Scholarship(s) are awarded in May. Families will be notified by telephone if they are selected as the recipient. Payment of the scholarship money is made directly to the family's selected preschool.
